MINUTES BOARD OF EDUCATION UNIFIED SCHOOL DISTRICT NO. 248 GIRARD, KS SPECIAL BOARD MEETING FEBRUARY 18, 2014

The Board of Education of Unified School District 248 met at the Board Office on Wednesday, February 18, 2014, for a Special Board Meeting to discuss Facilities Planning.

Vice-President, Aaron Callaway called the meeting to order at 5:30 pm. Superintendent, Blaise Bauer made a recommendation to proceed with a 16 million dollar bond issue, with a May 6, 2014 election date.

Gayle Price moved, Dale Shireman seconded the motion to accept the recommendation from Superintendent, Blaise Bauer, and to adopt "A RESOLUTION AUTHORZING AND PROVIDING FOR THE CALLING OF A BOND ELECTION IN UNIFIED SCHOOL DISTRICT NO. 248, CRAWFORD COUNTY, KANSAS (GIRARD) FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED ELECTORS OF THE DISTRICT THE QUESTION OF ISSUING GENERAL OBLIGATION BONDS OF THE DISTRICT; AUTHORIZING THE APPLICATION TO THE STATE BOARD OF EDUCATION FOR THE AUTHORITY TO CALL SAID BOND ELECTION; AND PROVIDING FOR THE GIVING OF NOTICE OF SAID BOND ELECTION." Motion carried. 7 – 0.

Greg Vahrenberg with Piper Jaffray; Ed Klock and Alan Milbradt with PBA Architects answered questions.

Dale Shireman moved, Beth Murphy seconded the motion for the election on May 6, 2014, to be a walk-in election. Motion carried. 7 - 0.

Dale Shireman moved and Beth Murphy seconded the motion to adjourn the meeting.
